Drive to Cape Sounio, known for its Temple of Poseidon, one of the major monuments of the Golden Age of Athens. Its remains are perched on the headland, surrounded on three sides by the Aegean sea. Wine tasting in Spata. Overnight Parthenon in Athens. Greek folk dancing. Overnight NJV Plaza Hotel in Athens.

**Day 4-5: Tuesday-Wednesday, October 7-8: See**



**Corinthian canal, archaeological site of Mycenae, theater at Epidaurus. Nauplia, Sparta, and Byzantine site of Mistra.**



Dinners, **folk dancing**. overnight in Nauplion at Amelia Hotel.

**Day 6: Thursday, October 9:** Drive through central **Peloponnese** Visit Palamidi castle. Ouzo tasting in Karonis. Visit a farm for the orange harvest. Walking tour of Nauplia, a Peloponnesian coastal city, capital of the regional unit of Argolis. Founded in antiquity, the city became an important seaport in the Middle Ages. Overnight at Hotel Liberty in Nauplion.



**Day 7: Friday, October 10:** Morning drive through Nafpakto. Visit archeological sites at Delphi. Dinner, folk dancing, Overnight in Fedriades hotel.

**Day 8: Saturday, October 11:** Morning visit to **Delphi museum**. Drive through **Arachova, Lamia, and Trikala**. Arrive in Kalambaka. Dinner, **folk dancing**, Overnight in Kalambaka: Amalia hotel.

**Day 9: Sunday, October 12:** Visit breathtaking cliff monasteries of **Meteora**. Rising from gigantic rocks, they appear as nature's gift to the pious who chose solitude and a life of worship. Lunch and **Greek folk dancing in a local Kastraki restaurant**. Return to Athens, passing through historic **Thermopyle**. Overnight at the NJV Athens Plaza.

He founded the Center for International Folk Dance in Oslo, and was professor of dance folklore at the Norwegian National College of Ballet, and University College of Oslo. Lee established folk dance and performing groups in Norway, taught at festivals and workshops throughout Europe, United States, and East Asia, and authored folk dance and instructional manuals for Norwegian schools. He was a choreographer for the Opening Ceremony of the Winter Olympic Games in Lillehammer.
