

#### Day 4: Tuesday, October 6

Visit of ancient Epidaurus, lunch and dancing with Nikos. Free time in Nafplion. Dinner and overnight in Nauplion at Liberty Hotel. (B, D)

#### Day 5: Wednesday, October 7:

Visit of Mycenae. Lunch and dance in Tolon Walking tour in Nafplion.

Dinner and overnight in Nauplion at Liberty Hotel. (B, D)

#### Day 6: Thursday, October 8: Nauplion-Olympia

Visit of ancient Nemea. Arrival in Olympia, wine tasting, honey, olive oil etc. Folk dance, dinner, and overnight in Asty Hotel. (B, D)



#### Day 7: Friday, October 9: Olympia-Itea

Visit of ancient Olympia, dancing with a local group. Overnight in charming seaside village of Itea. Dinner and overnight in Hotel Nafsika. (B, D)



#### Day 8: Saturday, October 10: Delphi-Kalambaka

Visit of Delphi, drive through Arachova, stop at Thermopylae. Arrive in Kalambaka. Dinner and dance at a local tavern. Overnight in Kalambaka, Hotel Kastrati. (B.D)

#### Day 9: Sunday, October 11: Meteora

Breathtaking cliff monasteries of **Meteora.** Rising from gigantic rocks, they appear as nature's gift to the pious who chose solitude and a life of worship. Visit two monasteries. Return to Athens. Overnight Electra Rhythm hotel in Athens.

Lee Otterholt, born in USA of Norwegian-American parents, has lived and worked in Norway





Lee established folk dance and performing groups in Norway, taught at festivals and workshops throughout Europe, United States, and East Asia, and authored folk dance and instructional manuals for Norwegian schools. He was a choreographer for the Opening Ceremony of the Winter Olympic Games in Lillehammer.

**Reservations:** Deposits and Payments: Deposit of \$200 per person is required at time of reservation. Balance is due 90 days prior to departure date.
